You are encouraged to register early as class sizes are limited. Registrations are processed in the order in which they are received. You will receive your registration confirmation via e-mail within 72 hours of receipt of your registration forms and payment. Payment is by credit card only. For security reasons, credit card numbers can only be taken over the phone. A representative will call you to gather this information after your registration is processed.

#### **Cancellation Policy**
